



Amalthea'17 CA Programme Terms and Conditions

This Agreement refers to Amalthea as "Amalthea," "we," "us," and "our". This Agreement refers to the applicant as "campus ambassador", "you" and "participant." This Agreement refers to Amalthea's name or logo as "Marks". This Agreement refers to the Amalthea Campus Ambassador Program as "Program." **This agreement is between you and Amalthea, and NOT the Indian Institute of Technology Gandhinagar.**

This Agreement refers to (1) all information about Amalthea and the Program, including any information disclosed to you by us, (2) any information, feedback, suggestions or ideas provided by you or generated in connection with the Program and your participation in the Program and (3) access credentials we may provide to access our systems as "Proprietary Information."

You will not disclose any of our Proprietary Information unless you have written authorization from us. Proprietary Information is any communication, whether verbal, written, electronic or otherwise, which is designated as confidential. You also agree to treat the terms and details of the Program as Proprietary Information.

You understand and agree that you are not an employee, agent, independent contractor or partner of Amalthea and that you will not represent or imply otherwise. You will only act under this Agreement in accordance with our instructions. If instructed by Amalthea, you will engage in activities to promote Amalthea. Such activities may include installing posters about Amalthea on your college bulletins and noticeboard(s), sending mass-emails to your campus community related to Amalthea, sharing our posts on various social platforms, getting students from your college to download our app, participate in our events and workshop, etc.

You agree to review any materials we provide to you and to comply with all of our instructions. Value. You acknowledge the unique value associated with your participation in the Program.

You agree that you will not identify yourself as an "Ambassador" or otherwise as participating in the Program to any third party unless we specifically authorize you in writing to do so. You will not issue any press release, use our Marks or otherwise make any statements or communications regarding the Program beyond what is specifically authorized through the program. You acknowledge that you have no rights in any material provided through or in connection to the Program.

You grant us a non-exclusive, transferable, sub-licensable, royalty-free, worldwide license to use your name, photographs of you and any other information about you that we have in connection with your participation in the Program.

We own all rights, title, and interest in and to all Proprietary Information. You agree to assign to us all right, title and interest in and to any program results (including any

information, feedback, suggestions or ideas) provided by you to us or by us to you or generated assignment. All program results are Amalthea's Proprietary Information in connection with your participation in the Program without compensation to you or any duty to account to you for such.

You understand that we may terminate our relationship with you at any time for any reason through notice to you.

You understand and agree that Amalthea may contact you through any method available, including through emails, mobile telephone (voice), Facebook, LinkedIn, Google+ and WhatsApp. You understand and agree that Amalthea will maintain a Google and Facebook group as well with all the Campus Ambassadors for the purpose of group communication.

Posters related to Amalthea will be provided to you by us. **Only if allowed by your institution**, you are supposed to put up these posters on the bulletins and noticeboard(s) of your institution, and you must send us pictures of the posters on the noticeboard. Whenever you send an email related to Amalthea, as a part of the Program, to the members of the student community of your institution, you must also CC or BCC the marketing coordinator of the Amalthea team. Whenever you make any non-verbal comment, via means other than an email, related to Amalthea, to any concerned person, you need to send us a screenshot of the same. This may include conversations over WhatsApp, messenger, slack or any such platform.

You are expected to like and share our posts on Facebook, re-tweet our tweets on Twitter, follow us on Google+ and share information, posts, updates regarding Amalthea etc. over WhatsApp groups or any other social media platform accessible to you and send us a screenshot of the same as per your convenience.

The procedure to be followed for the efficient flow of information (poster pictures, screenshots, etc.) between Amalthea and the Campus Ambassador will be declared through email to the appointed campus ambassadors.

You acknowledge and agree that you will not be financially compensated for participation in the Program.

We will not compensate you for any expenses incurred by you as a result of your participation in the Program. We may give notices to you. You agree to keep us updated in writing as to your contact information.

At all times you are performing under the Program, you will comply with all applicable laws.

The Program is provided to you "as is", without warranty, representation, condition or guarantee of any kind.

Amalthea will follow the following point scheme based on which the campus ambassadors will be analysed and rewarded for their participation.

* It remains to the discretion of Amalthea whether the proposed event from the campus ambassador be organised in the respective institution or not.

You will be eligible to receive personalised Amalthea merchandise free of cost and/or a campus ambassador certificate only if you comply with all the conditions in this agreement. We reserve the right to analyse the campus ambassadors based on the above mentioned point scheme and award personalised Amalthea merchandise and/or campus ambassador certificate at our discretion.

Internship opportunities will be offered to the top 20 participants of the program. The participants will be selected after an intensive screening by White Panda and at least 5 of the top participants will be provided with an opportunity with the option of working with White Panda for a period of at least two continuous months between December 2017 and August 2018. On the basis of merit and need of White Panda, more Campus Ambassadors may be selected of this programme.

You agree that the terms of this Agreement are included here and that no other terms will apply absent written authorization by us. We may change the terms of this Agreement by posting such revised terms or providing you with the terms. At that time, if you do not agree to the revised terms, you may terminate your participation from the Program. You understand and agree that your participation in the Program after such posting or notice will constitute to your acceptance of any revised terms.
